This privacy policy applies between (you) the users of this website and Tiger Communications plc, the owners and provider of this website. Tiger Communications plc takes the privacy of your information very seriously. This privacy policy applies to our use of any and all data collected by us or provided by you (the user(s)) in relation to your use of the website. Please read this Privacy Policy carefully.

## **Definitions and interpretation**

In this Privacy Policy, the following definitions are used:

**Data** - Data - Collectively all information that you (the user) submit to Tiger Communications plc via the website. This definition incorporates, where applicable, the definitions provided in the GDPR regulations and Data Protection Act amendments in May 2018.

We or us - Refers to Tiger Communications plc

**User / users or you** - Any third party that accesses the website and is not either an employee of, or employed by, Tiger Communications plc and acting in the course of their employment, or engaged as a consultant or otherwise providing services to Tiger Communications plc and accessing the website in connection with the provision of such service.

**Website** - The website that you are currently using, www.tiger.io, and any sub-domains of this site, unless expressly excluded by their own terms and conditions.

### Scope

This Privacy policy applies only to the actions of Tiger Communications plc and users (you) with respect to this website. It does not extend to any websites that can be accessed from this website, including, but not limited to, any links we may provide to social media sites.

### **Data collected**

We may collect the following data, which includes personal data, from you:

- Your name (first name and surname)
- Your company name / the name of the company you work for / are enquiring on behalf of
- Your location / the location of the company that you are enquiring on behalf of (city/town)
- Your email address / your company's email address for you
- Your contact telephone number / your contact number in relation to the company you are enquiring on behalf of
- Which products you are interested in / enquiring about
- The end point number(s) / licence number(s) you are enquiring for

In each case, in accordance with the privacy policy.

#### Our use of data

For purposes of the GDPR and Data Protection Act 2018 Tiger Communications plc is the "data controller".

We will retain any data you submit for a period of up to 21 months (due to the understanding of the business life cycle from the point of making an inquiry to the point of requesting a proposal), unless you become a maintained customer, in which case we will retain your details in relation to your contract with Tiger Communications plc.

Unless we are obliged or permitted by law to do so, and subject to any third-party disclosures specifically set out in this policy, your data will not be disclosed to third parties. This includes our affiliates and / or other companies within our group.

All personal data is stored securely in accordance with the principles of the Data Protection Act 2018 and the GDPR regulations.

For further information on security, please see the security section below.

Any or all of the above supplied data may be required by us, from time to time, in order to provide you with the best possible service and experience when using our website. Specifically, data may be used by us for the following reasons:

- To help you with your enquiry
- To respond to your request for a brochure / system demo / call back from one of our team
- If / where you or your company wish to enter into a maintained contract with Tiger Communications plc in purchase of our products

If / when you/your company becomes a customer under a maintained contract, and only then:

- To invite you to join our Tiger User Community as part of the service offered under your contract
- To invite you to our Tiger User Group Community events as part of the service offered under your contract
- To send you relevant information regarding your Tiger Communications plc system / contract, such as software updates and new product releases
- To send you quarterly newsletters about the products you have purchased, and the services Tiger Communications plc provide

In each case, in accordance with this privacy policy.

#### Third party websites and services

This website may, from time to time, employ the services of other parties for dealing with certain processes necessary for the operation of the website. The providers of such services may have access to certain personal data provided by users of this website. The information you provide to us may be passed to third parties located outside the European Economic Area. Countries outside the European Economic Area do not always have strong data protection laws. We will always try to ensure that your information is processed by third parties in accordance with this policy by using ICO approved binding corporate rules, EU-US privacy shield framework or similar.

#### Links to other websites

This website may provide links to other external websites. We have no control over such other external websites, and are not responsible for the content of these websites. This privacy policy does not extend to your use of such websites. You are advised to read the privacy policy or statement of other websites prior to using them.

#### Changes of business ownership and control

Tiger Communications plc may, from time to time, expand or reduce our business, and this may involve the sales and / or the transfer of control of all or part of Tiger Communications plc. Data provided by users will, where it is relevant to any part of our business so transferred, be transferred along with that part, and the new owners or newly controlling party will, under the terms of this privacy policy, be permitted to use the data for the purposes for which it was originally supplied to us.

We may also disclose data to a prospective purchaser of our business or any part of it.

In the above instances, we will take steps with the aim of ensuring your privacy is protected.

#### Controlling use of your data

Wherever you are required to submit data, you will be given options to restrict our use of that data. This may include the following:

- Use of data for direct marketing purposes; and
- Sharing data with third parties

#### Functionality of the website

To use all features and functions available on the website, you may be required to submit certain data.

#### Accessing your own data

You have the right to ask for a copy of any of your personal data held by Tiger Communications plc (where such data is held), providing it is not confidential, sensitive data pertinent to the Tiger communications plc business. For such request there may be a payment of a small fee required, which will not exceed £20.00.

Under article 17 of the GDPR you are able to request the right to be forgotten. In this instance we will uphold that right, so long as we do not have a justifiable legal reason to retain your data and any linked information. As an example, but not limited to, where you have been provided a service under contract by Tiger Communications plc, and records of that contract and related payments must be retained by Tiger Communications plc for a period of seven years.

#### Security

Data security is of great importance to Tiger Communications plc, and to protect your data we have put in place suitable physical, electronic and managerial procedures to safeguard and secure data collected via this website.

Tiger Communications plc are ISO2700:2013 certified, and you can view our certificate here.

If password access is required for certain parts of the website, you are responsible for keeping this password confidential – as per the details as out in our Terms & Conditions page.

We endeavour to do our best to protect your personal data. However, transmission of information over the internet is not entirely secure and is done at your own risk. We cannot ensure the security of your data transmitted to the website.

#### General

You may not transfer any of your rights under this privacy policy to any other person. We may transfer our rights under this privacy policy where we reasonably believe your rights will not be affected.

If any court or competent authority finds that any provision of this privacy policy (or part of any provision) is invalid, illegal or unenforceable, that provision or part-provision will, to the extent required, be deemed to be deleted, and the validity and enforceability of the other provisions of this privacy policy will not be affected.

Unless otherwise agreed, no delay, act or omission by a party in exercising any right or remedy will be deemed a waiver of that, or any other, right or remedy.

This agreement will be governed by, and interpreted according to the law of England and Wales. All disputes arising under the agreement will be subject to the exclusive jurisdiction of the English and Welsh courts.

## Changes to this privacy policy

Tiger Communications plc reserves the right to change this privacy policy as we may deem necessary from time to time, or as may be required by law. Any changes will be immediately posted on the website and you are deemed to have accepted the terms of the privacy policy on your first use of the website following the alterations.
